## THE LAW ABOUT "ACCOUNTS AND SECURITY/SAFTEY BOX SYSTEMS" HAS ENTERED INTO FORCE

The Swedish Tax Agency has been commissioned by the government to be responsible for the technical platform (**Mekanismen**) that authorities must use to identity accountholders and safes in financial companies.

All financial institutions that are affected by the law need to provide a service/API that the Swedish Tax Agency can access. Specification of how the institute's API should be designed is determined by the Swedish Tax Agency. Read more on the <a href="Swedish Tax Agency">Swedish Tax Agency</a>'s website. (Swedish link)

#### **DEVELOPMENT SUMMER / AUTUMN 2020**

Development continues regarding KYC. This will be integrated with CM1 and the information can be used directly for risk classification of customers.

CM1 also has a new case type for KYC cases that can be created, for example, if the risk changes. If you want to know how this can be configured, contact our support.

During the summer, we also continued to develop SCO (Sanction control ownership), ie. if there is ownership in a company that is linked to a sanction.

We have continued to develop the real-time monitoring module that we demonstrated in our webinar in May.
